### **Guidelines on filling the Application Forms for Registration of Contractors with the Ministry of Public Infrastructure, Land Transport and Shipping (Public Infrastructure Division)**

#### **Application Forms:**

- (i) [Registration/Upgrading for the undertaking of Building, Roads Works and Other Works](#)
- (ii) [Registration for the undertaking of Minor Works](#)

Any Contractor wishing to be registered with the Ministry of Public Infrastructure, Land Transport and Shipping (Public Infrastructure Division) may call at the Architect Section at Phoenix to collect the application form(s) or may download same from the website of the Ministry on the following address:

- (a) Item no. 1:- **Type of work to be undertaken**

The applicant should indicate clearly the work(s) undertaken by him/the company according to those specified in the Job Contractor's Permit issued by the Ministry of Labour, Industrial Relations and Employment provided the work(s) mentioned therein is/are in conformity with the categories of works mentioned at [Annex I](#).

- (b) Any application for any category of work not appearing at Annex I will be rejected.
- (c) The applicant should ensure that: -
  - (i) items no. 1 to 13 on the application form for the undertaking of building, road works and other works and items no. 1 to 12 on the application form for the undertaking of minor works are duly filled and supported by any additional information/document that may be available;

- (ii) the application form is signed and dated at page 4;
  - (iii) the Financial Standing, for which a specimen is at page 5 of the application form, should be submitted under **letter head** of the bank **in original, duly signed**, and should bear the **official bank seal**; and
  - (iv) all documents (whichever is applicable), listed at page 6 of the application form, are to be produced at the same time of submission of application form.
- (d) Contractor(s) are not allowed to tender for government projects launched prior to their registration date.
- (e) Foreign Contractor(s) are allowed to tender only for government projects financed by International Funding Agencies subject to the approval of the Funding Agencies.
